Requirements for Construction Documents

Submittal documents.

Residential construction documents and other data shall be submitted in two or more sets with each application for an approval. Before beginning the construction of any residential building for which construction documents are required the owner or the owner's representative shall submit construction documents to the residential building official for approval. When construction documents have been found to be in compliance with the rules of the Board of Building Standards in accordance with Section 105.5 by a certified residential building department, that compliance shall be deemed sufficient to obtain approval for construction.

106.1.3 Information on residential construction documents.

Residential construction documents shall be dimensioned and drawn upon suitable material. Construction documents shall be coordinated and of sufficient clarity to indicated the location, nature and extent of the work proposed and show in detail that it will conform to the provisions of the Residential Code of Ohio. Construction drawings shall include information necessary to determine compliance with the building, plumbing and fire protection codes such as:

- Elevation plan showing footer, foundation, walls and roof
- Materials being used (framing, drywall, ceiling, etc)

Room Addition
